TOWN BOARD MEETING

Approved Minutes

Monday August 10, 2015

-Chairman Wiese called the meeting to order at 7:00pm.

-The Pledge of Allegiance was recited.

-Roll call of officers was taken. Chairman Terry Wiese, Supervisors, Andrew Tomaszewski & Bob Steigerwaldt. Treasurer, Julie Allen and Clerk, Donna Edwards were present.

-Motion to approve the agenda as printed by Steigerwaldt/Tomaszewski. All Ayes.

-Voucher Approval-Motion by Tomaszewski/Wiese to approve and send out all vouchers. Tomaszewski, aye, Wiese, aye Steigerwaldt, No. Steigerwaldt to hold American Asphalt and Highway Maintenance so he may review the bills closer. Tomaszewski made the motion to pay all bills as submitted to enable the board to go forward with the submission to Madison for the Trip-D Program for Pickeral Creek Road. Wiese 2nd. Tomaszewski, Aye Wiese, Aye Steigerwaldt, No.

-Treasurers report. Cash summery \$185,703.89, deposits \$22,070.71, withdrawals \$20,404.06 leaving an ending balance of \$187,370.54. Tomaszewski/Steigerwaldt accepted into record. All Ayes. Treasurer and Clerk balanced as of July 31, 2015.

-Approval for July 13, 2015 Meeting Minutes. Stiegerwaldt made the motion to approve minutes with one correction. Tower on Hwy. H should have read Hwy. A Wiese 2nd. All ayes.

-Clerk received correspondence from Verizon regarding any town charges for the addition of a microwave dish to the existing tower on Hwy. D. None on record at this time. Clerk received correspondence from Towns Assoc. Quarterly Towns Group asking for a \$25.00 annual fee. Steigerwaldt/Wiese move to pay \$25.00 and to volunteer to host an upcoming meeting. All Ayes

Old Business

-Three driveway permit was issued in July, 2015.

-Private Road snowplowing. Add set annual price to cover sheet.

-Lund Driveway. Steigerwaldt to draft letter to Lund family, to be approved by the board, and sent telling them that the work must be completed by October 1, 2015. Steigerwaldt/ Wiese motion. All Ayes.

-Eagle Bay Road-Before road can be considered as being a Town Road, A certified survey map, with description included is required. Land owners are looking into.

-Spring Creek Damage. Invoice for damages, certified letter was returned with "unknown address". Clerk to contact Sherriff's Dept. to check on it.

New Business

-Calllahan Road. Chairman Wiese contacted Town of Harrison, Charles Phelps concerning charges for snowplowing their portion of the road. Chairman Phelps agreed the Town of King should plow the entire road and send them a bill for the plowing. Steigerwaldt/ Wiese moved to bill the Town of Harrison at the end of the plowing season at a rate of \$100.00 per hour with a minimum being ½ hour. All Ayes.
